<p>Lars-Erik Liljelund <i>The Prime Minister's special envoy on climate Change</i></p>	
<p>Kristie L Ebi <i>Executive Director of the Technical Support Unit for Working Group II (Impacts, Adaptation, and Vulnerability) of the Intergovernmental Panel on Climate Change (IPCC).</i></p> <p>Dr Ebi has been conducting research on the impacts of and adaptation to climate change for more than a dozen years, including on extreme events, thermal stress, foodborne safety and security, and vectorborne diseases. She has worked with the WHO, the UNDP, USAID, and also facilitated adaptation assessments for the health sector for the states of Maryland and Alaska. She is lead author on the "Human Health" chapter of the IPCC Fourth Assessment Report, and the "Human Health" chapter for the U.S. Synthesis and Assessment Product "Analyses of the Effects of Global Change on Human Health and Welfare and Human Systems."</p> <p>She has edited four books on aspects of climate change and has more than 80 publications. Dr. Ebi's scientific training includes an M.S. in toxicology and a Ph.D. and a Masters of Public Health in epidemiology, and two years of postgraduate research at the London School of Hygiene and Tropical Medicine</p>

Mr Lind is also Chairman for the R&T Directors in the European Defence Agency (EDA). Previous assignments are among others; the National Armaments Director of Sweden, Deputy as well as Director General for the Swedish Defence Materiel Administration (FMV) between 2003 and 2007 and Director at the Ministry of Defence, Department for Military Affairs.</p>	
<p>Helga Maria Schmid <i>Director of the Policy Planning and Early Warning Unit (Policy Unit) of the High Representative Javier Solana in the General Secretariat of the Council of the European Union, Brussels</i></p> <p>Deputy head as well as head of the Political Staff of the Federal Foreign Office in Berlin and Head of the Minister's Office. During 1994 – 2000 she served as political advisor to the Foreign Ministers in Germany. She studied at Munich and Paris University and also international and European law, economics and international relations at the Diplomatic Academy.</p>	
<p>Johan Schaar Dr. Schaar was the Special Representative for the Tsunami Operation of the International Federation of Red Cross and Red Crescent Societies (IFRC), Geneva, in 2005-2007. In 2000-2004 he was the Head of Division for Humanitarian Assistance and Conflict Management, Sida, Stockholm. In 1987-2000 he undertook a number of assignments for the IFRC, Swedish Red Cross and the Swedish Committee for Afghanistan. He holds a PhD from the Swedish University of Agricultural Sciences.</p>	

Mr Pekka Haavisto

During the recent years Mr. Haavisto has been working for the Darfur Peace Process; as the first EU Special Representative for Sudan (2005-2007) and as a UN Senior Advisor for the Darfur peace process (ASG level).

1999-2005 Haavisto worked for UNEP, chairing several post-conflict assessments and identifying and addressing the problems to the human health and livelihoods in the worst humanitarian crises areas in the world. The assessments were made in the Balkans after the Kosovo conflict, in Afghanistan, in Iraq, in Liberia, in the Occupied Palestinian Territories, in Africa's Great Lakes area and in Sudan.

Mr. Haavisto is a former Finnish Minister for Environment and Development Co-operation.

**Dan Smith**

Having graduated in 1973 from Cambridge University where he read English Literature, Dan's work on peace issues started when he began research on UK defence policies in 1976. Prior to joining Alert Dan held a number of senior positions, most notably as Director of the International Peace Research Institute in Oslo from 1993 to 2001. He also held fellowships at the Norwegian Nobel Institute and Hellenic Foundation for Foreign and European Policy and was for over a decade the Chair of the Institute for War and Peace Reporting. Dan is a prolific author and since arriving at Alert he has continued to publish widely. All told he has authored, co-authored and edited sixteen books including successive editions of The Atlas of War and Peace. Responsible for over 100 journal articles and chapters in anthologies he is also regularly invited to advise governments and international organisations on policies and structures for peacebuilding, including through his membership of the Advisory Group for the UN Peacebuilding Fund. At Alert he produced the path breaking A Climate of Conflict (2007) report on the links between climate change, peace and war and continues to lead the organisation's advocacy on a range of issues critical to the reduction of conflict and building of peace. Mr. Abdoulie Janneh

Mr. Abdoulie Janneh (Gambia) is Under-Secretary-General and Executive Secretary of the United Nations Economic Commission for Africa (ECA). ECA has a dual role as the regional arm of the United Nations in Africa and as a key pan-African institution. Since Mr. Janneh joined ECA, he has taken steps to strategically reposition the organization to better support Africa's development agenda. He has also overseen the articulation of the ECA Business Plan 2007 – 2009 to operationalize the new strategic vision.

Before joining ECA, Mr. Janneh served as Assistant Secretary-General and UNDP Regional Director for Africa from June 2000 to October 2005. In that capacity, he managed United Nations Development Programme's (UNDP) largest Regional Bureau, covering 45 countries in sub-Saharan Africa with a complement of over 1,500 staff. Prior to that, he held a number of senior positions in UNDP and its affiliated funds, including Resident Coordinator and Resident Representative in Ghana (1996-1999) and Niger (1993-1996), as well as Deputy Executive Secretary of the United Nations Capital Development Fund (1990-1993).

As a senior UN manager, Mr. Janneh has been a strong advocate for development efforts that respond effectively to Africa's national and regional priorities. Under his leadership, ECA has taken significant steps to support African countries in the area of regional integration, poverty eradication, trade, financing for development, ICTs, governance, statistics, climate change, the fight against HIV/AIDS, and natural resources management. Mr. Janneh remains particularly interested in the institutional transformation of the African Union and the successful implementation of the New Partnership for Africa's Development (NEPAD), including the Africa Peer Review Mechanism (APRM), as critical initiatives for achieving the Millennium Development Goals.

Mr. Janneh has been striving to enhance partnership-building for Africa, as a necessary vehicle to mobilize support and build inclusiveness for shared development objectives. In this regard, he has been able to cultivate strong partnerships at the highest levels between ECA and governments, the private sector, civil society, as well as national, regional and international organizations. He also serves on the advisory panels of a number of organizations involved in Africa's development and has delivered over the years a number of keynote addresses, policy statements and written articles on issues germane to Africa's development.

Dr A. Atiq Rahman

Dr A. Atiq Rahman is the Executive Director of Bangladesh Centre for Advanced Studies (BCAS) and a Lead Author of Intergovernmental Panel on Climate Change (IPCC) Fourth Assessment Report (AR4) Chapter-19 on “Assessing Key Vulnerabilities and the Risk from Climate Change”. He played a leading role in UNCED, Rio, 1992, Intergovernmental Negotiations on Climate Change (INC) session and all the Conferences of Parties and Climate Summits in Kyoto, 1997 leading to Kyoto Protocol. He was also a lead author of the IPCC Third Assessment Report and IPCC Special Report on Technology Transfer and cross cutting paper on “Development, Equity and Sustainability”.



He was a lead author of the IPCC Fourth Assessment Report, which received Nobel Peace Prize and the Award has been endorsed by the IPCC to lead authors to share the magnitude of the award with them.

For his “outstanding and inspirational leadership in the field of environment” The United Nations Environment Programme (UNEP) has honoured Dr A. Atiq Rahman with “Champion of the Earth,” the highest UN award on environment for the Asia Pacific region.

He was also conferred the ‘**Environment Award 2008**’ from Department of Environment, Government of Bangladesh for his extensive research work at local national and global level; scientific and technological innovation.

Dr Rahman is a Visiting Professor of International Diplomacy and Sustainable Development at Fletcher School of Law and Diplomacy, Tufts University, Boston, USA. He is the Chairman of Climate Action Network South Asia (CANSA). He is also the Chairperson of Coalition of Environmental NGOs in Bangladesh. Presently, he is engaged in exploring the global-local linkages and mega-processes such as global equity and poverty issue, climate change, bio-diversity, institutions and capacity building and global scenarios. He was the Team Leader of National Adaptation Plan of Action (NAPA) Synthesis Group, Government of Bangladesh.

He was born in Bangladesh in 1950. He was trained as a chemist with early education in B.Sc Hons. and M.Sc from Dhaka University. He was awarded the Commonwealth Scholarship 1974 and completed his Ph.D on solid state chemistry and low energy processes from Brunel University, London, UK in 1977. For fourteen years (1974 - 1988) he taught and researched in the Universities of Oxford and Aberdeen in UK and Haute Alsace in France. During his scientific career in Europe he was awarded (a) the “Thermal Methods Group Award” in 1984 by the Royal Society of Chemistry and (b) “Sir Eric Rideal Award” in 1985 by the Society of Chemical Industries, London (c) Royal Society, London gave the award for lecturing on Advanced Ceramics in several Universities in Japan during 1986. He designed, developed and taught a multi-disciplinary postgraduate course on “Sustainable Development Challenges and North South Dialogue” at Massachusetts Institute of Technology (MIT), Cambridge, USA.

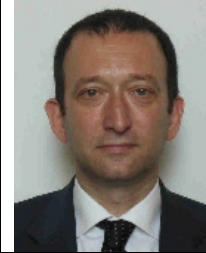
