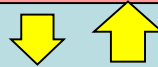


- **Consultation** with Policy DGs, Agencies, Member States, Networks, Projects: Chair / Involvement in Thematic Groups

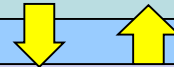
HIGH-LEVEL STEERING BOARD

Policy initiatives, guidance, Strategic Implementation Plan, endorsement of recommendations



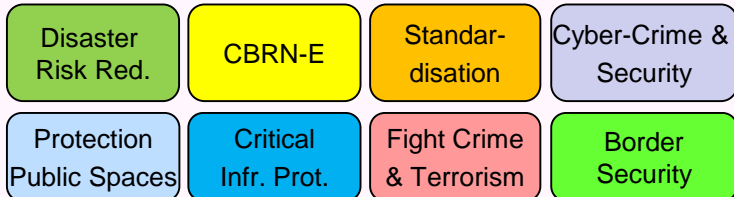
COORDINATION BOARD

THEMATIC GROUPS (ThGs)



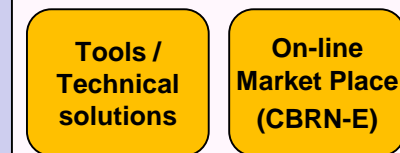
Representatives of respective policies, EU-funded projects, industry/SMEs, Practitioners, DGs
